

# **Notice of Public Hearing on Increasing Property Taxes**

## **Truth in Taxation Notice**

The Village Council of the Village of Lake Orion will hold a public hearing on a proposed increase of 0.2868 mills in the **General Operating** tax millage rate to be levied in 2021.

The hearing will be held on Monday, May 10, 2021 at 7:30 p.m.

***All meetings and public hearings for the Village of Lake Orion will be conducted virtually through June 30, 2021 due to health concerns surrounding COVID-19 as permitted by MCL 15.263 of Public Act 254 of 2020, the Open Meetings Act, as amended due to the Village of Lake Orion State of Emergency.***

The date and location of the meeting to take action on the proposed additional millage will be announced at this public meeting.

If adopted, the proposed additional millage will increase operating revenues from ad valorem property taxes 4.37% (\$66,117) over such revenues generated by levies permitted without holding a hearing. If the proposed additional millage rate is not approved the operating revenue will increase by 1.55% (\$22,387) over the preceding year's operating revenue.

The taxing unit publishing this notice, and identified below, has complete authority to establish the number of mills to be levied from within its authorized millage rate.
